INSTRUCTION FOR ABSTRACT FORMAT AND PREPARATION

Organization of Abstract:

Title: Please type title and bold letters, capitalize only the first letter of the first word, and center on the width of the typing area and single-spaced if more than one line is required. The title should be brief, descriptive and have all words spelled out.

Authors: Please list the author(s) name(s), single-spaced if more than one line is required. Underline and use bold format for the name of the presenter. Put asterisk sign "*" after the name of corresponding author.

Author's Affiliation: Please indicate institutional affiliation followed by city and country. In case that authors are from different institutions, please use number typed in superscript for each institution and author accordingly.

Keywords:

Please list up to 5 keywords that best match the core content of the abstract.

Abstract body:

- The authors must specify the track that is closely related to your work. You can only choose 1 track from a total of 6 tracks. These tracks include as the followings.
 1. Pharmacy Education (PE)
 2. Pharmaceutical Chemistry (PC)
 3. Pharmaceutics & Drug Delivery System (PD)
 4. Biopharmaceutical Sciences and Pharmaceutical Biotechnology (BB)
 5. Natural Products (NP)
 6. Clinical Pharmacy / Social and Administrative Pharmacy (CS)
- Please organize the abstract body into the following sections; Introduction, Objectives, Materials and Methods, Results and Conclusion. Each section must contain enough significant data to be evaluated by reviewers specialized in that field.
- Text should be single-spaced, and double-spaced between sections (Introduction, Objectives, Materials & Methods, Results and Conclusion).
- Figures and tables are not allowed in the abstract.
- The total length of abstract body **cannot exceed 350 words**.
- Please see the example of abstract at the last page.

Abstract Submission:

All abstracts must be submitted online via the official website of the conference.

The deadline for abstract submission is 15 August 2015. Any communication in case of questions or concerns should be sent to the Chairman and Secretariat of the Scientific Committee at aseanpharmnet.sci@gmail.com

Proceedings:

After the submitted abstracts are reviewed by the Scientific Committee and accepted to be presented at the Conference, the authors can submit the full papers which will be reviewed by the Scientific Committee. Only accepted abstracts and full papers will be printed in the Conference Abstracts and Proceedings. In addition, only selected full papers will be published on the Mahidol University Journal of Pharmaceutical Sciences.
